

*John Tripp (1) was born in Northumberland County, England in 1610, died 1678. He married Mary Paine, daughter of Anthony Paine.
Mary died Feb. 12, 1687. Settled in Portsmouth, R. I. John (1) was a carpenter.

1638 - He was admitted an inhabitant of the island of Aquidneck (R.I.). 1639, Apr. 30 - He signed a compact with twenty-eight others as follows: "We whose names are underwritten do acknowledge ourselves the legal subjects of his Majesty King Charles, and in his name do hereby bind ourselves into a civil body politic, unto his laws according to matters of justice."

1643, Mar. 1 - He was granted three acres of land next to Thomas Gorton.

1648 -54 -55 -58 -61 -62 -63 -64 -66 -67 -68 -69 -72. Deputy.

1649, Oct. 27 - He and wife Mary gave receipt to Rose Weeden, widow of Anthony Paine, for lagacy from will of the latter. Richard signed of also

1655 - Commissioner.

1655 - Freeman.

1657, Nov. 30 - He had a grant of land on Hog Island for a term of se-

ven years.

1660. Feb. 6 - He, calling himself about forty-nine years old, gave testimony that he had heard his uncle Robert Potter say he had sold a certain house and land to John Anthony.

1665, Sept. 8 - He deeded son Peleg (2), one-quarter of a section of

land in Dartmouth, formerly bought of John Alden.

1666, Dec. 8 - Whereas, Mary Tripp, wife of John Tripp, Sr., some twenty-five years ago bought of Richard Searle for a pint of wine 3 acres of land, the said Richard Searle living then in Portsmouth, being then unmarried, about which time Searle removed but left no deed to Mary -- now therefore said sale is confirmed by commission-

1670 -73 -74 -75. Assistant.

1671, May 3 - He deeded son Joseph (2), one-quarter of a section of land in Dartmouth, formerly bought of John Alden.

He was a member of Town Council and held other town offices.

1677, Dec. 6 - Will proved 1678, Oct. 28. Exx. wife Mary. estate, lands, goods and chattels, movable and immovable, during her natural life, "only my old house excepted or north end of my building which I have given to my son John Tripp (2) formerly." To son John, house and lot and 10 acres in the Clay Pit field, meadows at Hog Island, all fencing, houses, orchard, etc., "excepting my new house or south end of my building", etc. Abiel (2), south end of building last mentioned with lot adjoining and other land. To son Peleg (2), 5 pounds. To son Joseph (2), 10 pounds. To son James (2), one-eighth of a share of land at Dartmouth and rights in Narragansett and Westerly. To daughter Martha (2), 20 pounds. To granddaughter Elizabeth Wodell (3), 10 pounds.

PART III

*Peleg Tripp (3). Mrs. Hammer (10) of 286 Tillon Road, South Orange, New Jersey, has been of real assistance here. Her line from Acus (5): Acus Tripp (5), Johnathan (6), Sarah Tripp (7), Sarah Bassett (8), Sabrina Ann Sisson (9), Emily Augusta Thompson Hammer (10). I will quote from her, as she has given us (to date) the only connection between Peleg Tripp (3) and Benoni Tripp (4). Mr. Hammer writes:

"I had quite an extensive correspondence with Mr. Thomas A. Tripp, Vice President of the Pairpoint Corporation, of New Bedford, and he told me he had found a manuscript on the descendents of Joseph Tripp (2), third son of the original John (1), prepared by Mr. Randall (then deceased) former librarian of the New Bedford Public Library. There had previously been printed a similar book regarding the descendents of James Tripp (2), John's (1) 10th child. Unfortunately Mr. Randall did not give his sources of information, but the manuscript is still in the New Bedford Library. The following is what he sent me regarding Peleg (3) and Benoni (4):

'Peleg (3) - born Nov. 5, 1873. Died 1761.

Married (1) - - -

(2) Jan. 29, 1712 - Elizabeth Cornell, dau. of Stephen and Hannah (Mosher) Cornell.

Children:

Othniel (4) b. July 23, 1697.

Experience (4) m. Joseph Brownell.

Benoni (4).

Priscilla m. - Rogers.'"

(The manuscript is in the library. C.D.T.)

We know that Peleg (3) had a son Othniel (4), as the Dart-mouth marriages state that "Othniel, s. Peleg Tripp of D. and Abigail Jenkins of D. dec'd, 28th, 9 mo. 1745".

Dartmouth marriages also state "Peleg Tripp and Elizabeth Cornell, second w, ____, Jan. 29, 1712".

(To follow the line of thought accepted in geneological research and in historical organizations such as the S.A.R. we may strengthen the above by also making the Peleg (3) - Benoni (4) connection through deduction or "circa" - about. So far as I have been able to find out, there were only two of the name Benoni Tripp, and one was the grandson of Acus Tripp (5). Also, the name Acus Tripp and the name Benoni Tripp are so peculiar and unheard of that there is no reason why we cannot assume that those names appearing on different occasions during the same respective periods at the same locations belong to the same men.)

*Acus (or Akus) Tripp (5) of Dartmouth, Mass. and Tiverton, I. married Sarah Godfrey of Chatham Mass. in Chatham, Sept. 3, 1754. See those township records.) Associately Dennis V.R.

In the same manuscript by Mr. Randall in the New Bedford (forrly Dartmouth) Public Library we find "Acus Tripp (5) ---, died Mar.
), 1807 - is said to have been in expedition that captured Louisburg
1 Cape Briton from the French in 1754". The names of the children of
1 cus Tripp (5) listed in this manuscript, with the exception of William
1 ipp (6), are the same as those in our family records to follow.

This is historical fact: After the French and Indian Wars and ter the French were defeated in Canada, the British made an attempt to ttle Nova Scotia with their own countrymen. A company from Massachuttes and many from Cape Cod went there and settled.

The grant of the township of Liverpool, Queens County, Nova otia finally passed November 20, 1764. This grant of 100,000 acres is given to 142 proprietors, each of whom received as his share 500 acres. One extra share each was reserved for the Church of England and or Schools.

The archivist of Nova Scotia verifies the fact that Acus Tripp i) was one of these original proprietors. He returned to Cape Cod abut the time of the Revolution, because the name of Tripp had disapared from Queens County at the census of 1787; he fought on the Ameran side in the Revolution.

Alonzo Tripp (8)(deceased) of Boston, grandson of Reuben Tripp i) states "Acus Tripp (5) sold two of his lots and made exchange of ather, as recorded in the Registry of Deeds in Linport, Nova Scotia".

The following from "Massachusettes Soldiers and Sailors of me Revolution", Vol. XVI:

Acus Tripp - (Corporal) Capt. Simeon Fowler's Comp., Col. Reed's (1st) Reg't. of Guards; muster Roll dated Cambridge, May 9, 1778. Enlistment, 3 months from April 2, 1778; (Also), same Co. and Reg't; entered service April 4, 1778; Service to July 8, 1778, 3 mo's, 3 days, at Cambridge; (Also) (Private), Capt. Elijah Smalley's Co., Maj. Zenas Winslow's Reg't; service, 6 days, on an alarm at Bedford and Falmouth in Sept. 1778; Roll sworn to in Barnstable Co. (See "Asus Trip".)

"Asus" Trip - Corporal, Capt. Seth Clark's Co; service between July 1, 1775 and Dec. 31, 1775. 6 mo's. 10 days in defense of sea coast. Roll sworn to in Barnstable Co.

An Acas Tripp (5) is shown as living in Yarmouth, Cape Cod, in e U. S. Census of 1790.

It is fitting that we insert here the line of Carleton O. Tripp O) of Little Falls, N. Y.

Acus Tripp (5); William Tripp (6); Samuel Tripp (7); Lewis E. Tripp (8), born April 1, 1838 and known to Miss Nora Tripp (9) as "Uncle Lou Ed"; Allen Gideon Tripp (9), born Nov. 12, 1868, d. July 28, 1912 - graduated Syracuse Medical College 1900 - began practice Cicero 1900; C. O. Tripp (10), born Sept. 2, 1902.

Carleton has the family Bible of Samuel Tripp (7) in which there is pasted the "Statement of Johnathan Tripp, Dec. 19,1881." (7). I obtained a photograph of this statement and am placing two copies in my safe deposit box, sending one copy each to Miss Nora Tripp, Mr. Geo. McClean and Mr. Scott Tripp. This as a guarantee against loss of record.

The statement in part is as follows:

"Aces Tripp (5) Hailed from R. I. In time of Revolution was at Wildfleet, residence (probably Wellfleet, Cape Cod). Was wounded at Bunker Hill with Grape Shot.

"Sons.

"1st Johnathan Tripp (6) was in war of Revolution lost a Leg at the Battle of Cowpens, was taken prisoner by the Hessians. Escaped by Shooting one of his Captors. Returned to his Command & lost a leg by Cannon Ball, was Drowned at Sea.

"2nd Samuel (6) lived & Died at Harwich.

"3rd Reuben (6) think he was Drowned at Charleston, S. C.

"4 Jeptha (6) think he was Drowned.

"5 Godfrey (6) Settled and went to Charleston, S. C. with fa-

mily.

"6 William (6) Born July 7, 1770 ---- three children at Cape Cod Moved from there to Hawley Mass. there Bought a Farm used to Carry Flax Butter Cheese Escence, Produce of his Farm, to Cape Cod (in the) Summer Fishing Season (and) stayed weeks & winter Mother went to Cape Cod with him and took Sylvanus with her Moved to Cicero 1824 arrived----July 25th, 1824----."

PART VI

The first we hear of *William (6) is from the vital of the town of Dennis, Mass. (Cape Cod). These read "William Trip (6) and Polly, his wife. A record of the births and names of their child-ren. Thankfull Trip (7) born February 7, 1794." Dennis at that time was part of the town of East Yarmouth, according to the town clerk.

We next find William (6) in Hawley, Mass. in the Berkshire The records of Hawley and Samuel's (6) Bible tell us: Hills.

William Tripp (6) born July 7, 1770.

Mary Rathborne, his wife, Born November 20, 1772. Thankful Rathborne, their daughter, born February 7, 1794 (7). Died March 15, 1860.

Polly (7), their daughter, born June 25, 1797. Died December 7. 1882.

William Jr. (7), their son, born August 25, 1801. Died April 1886.

Sally Goodfrey (7), their daughter, born April 11, 1803. Died June 7, 1836.

Irene Crowell (7), their daughter, born August 2, 1805. Coggswell Rathborne (7), their son, born August 28, 1807. Roseanna D. (7), their daughter, born December 30, 1809. Samuel Godfrey (7), their son, born May 9, 1812.

Jonathan (7), their son, born March 10, 1814. Died February 5, 1892.

Sylvanus (7), their son, born February 5, 1816. Died March 1, 1851.

From Atkin's "History of Hawley, Mass,", Loren Longley married Thankful Tripp (7) and had Lucy, born May 5, 1819; Elizabeth, born April 28, 1821, died July 8, 1822; Lorenzo, born October 16, 1824; Elizabeth, born April 30, 1826.

Franklin County, Mass., registry of deeds records on September 9, 1820 in book 46, page 104, that for the consideration of \$100 (in Hawley) William Tripp sold to Samuel Rathbone 1 3/4 acres, "bounded on Edward Baxter's land, Chickley's River, Alpheus Hawks." In book 36, page 300, for the consideration of \$250 (in Hawley) William Tripp (6) sold to Samuel Rathbone 20 3/4 acres (recorded September 3, 1816). Bounds: "west on Chickley's River, north on Edward Burton's land, east on my land, south on Alpheus Hawks land."

Stephen Tripp (8) verifies the Hawley residence. His father * Cogswell was born there. Family records of David A. Tripp (9) give Cicero, New York as the birthplace of his father, Charles R. Tripp (8). This among other facts verifies William's (6) residence in Cicero.

Mrs. Millie Smith of Cicero (grand-daughter of Irene (Tripp) Noble (7), gives the same family records as those of Hawley with the following changes: Rathborne is Rathbone, Coggswell Rathborne Tripp (7) is Rathbone Tripp, Irene is Irena, Roseanna is Roxana and the last child Daniel Tripp (7) was born February 27, 1822.

Mr. J. Elmer Tripp (8) of Marietta, New York, son of Daniel (7) gives me the following facts: William Tripp (6) and Mary Rathbone were married Nov. 6, 1792. J. Elmer Tripp married Daisy Frances Moore, a teacher. He has a son about 25 years old living with him; wife is dead. The son is Stuart Tripp (9). Daniel Tripp married Irena Hashall. Elmer (8) says that a great many of the present inhabitants of Cicero are related to our Tripps. Sylvanus Tripp (7), who died at the age of 25 in 1841, had been bitten by a rattlesnake in the Cicero swamps. The effect of this caused his death seven years later. Elmer has a shaving box fashioned by William (6) while he was at sea. Says William (6) owned a whaling vessel, as did others of the family.

William Tripp (6) was the great-grandfather of M. H. Noble, Grand Rapids, Michigan and his sister Cora Coker of Spokane, Washington. (From them.)

From the headstones in Stone Arabia Cemetery, Cicero:

Sylvanus Tripp (7) born February 5, 1816. Died February 28, 1841.
William Tripp (6) born July 7, 1770. Died September 2, 1843.

Many Tripp born November 20, 1775. Died November 1, 1849.

Mary Tripp born November 20, 1775. Died November 1, 1849.

Miss Nora Tripp (9) states that Cogswell Tripp (7) was a Wesleyan Methodist exhorter; carpenter by trade. That he and Lewis built the Wesleyan Methodist Church in Seneca Falls, New York.

Following inscriptions in the Medcalf Cemetery, Seneca Falls: "Mary Stimpson, mother of Lucy S. Tripp, died February 22, 1878. Aged 84. Rev. Cogswell R. Tripp (7) died March 12, 1888. Aged 80 years, 6 months. Lucy S., wife of Rev. C. R. Tripp died June 14, 1889. Aged 74 years, 6 months."

Will of Cogswell R. Tripp (7), New York. "Seneca County will (1888) of the village of Seneca Falls. It gives use of all real and personal ----- to wife Lucy, with power to deed or mortgage the estate if the use be insufficient for support. After Lucy's death, all to be divided among heirs, \(\frac{1}{4}\) to a son, Charles Tripp (8); a daughter, Ann Elizabeth Cook (8)(Hook); Ella Tripp, daughter of Lewis J. Tripp (8); Myrtie Tripp, wife of Stephen Tripp. The executor was Lewis J. Tripp."

Mary M. Tripp (8) died September 15, 1862. Aged 20 years, 5 months.

David W, Tripp (8) killed at Gettysburg July 6, 1863.
Aged 18 years, 5 months.

D. W. Tripp (8) Co. A 121st Pa. Inf. Ann E. (Tripp) Hook (8) 1835-1929.

Stephen F. Tripp (8) living in Ithaca, New York, 1934.

Miss Nora Tripp (9) says that C. R. Tripp (8) went to Pleasantville, Pa. with his father during the oil boom, where they worked for a while at their trade as coopers. He married Martha Watson, Jan. 16, 1869. at Pleasantville, Pa.

C. R. Tripp (8) mentioned as enrolled in the 4th Pa. Cavalry in history of Venengo Co., Pa. Name "Sergeant Charles Tripp" on Pa. monument at Gettysburg as is name of D. W. (8).

War Department, Washington:

"Charles Tripp (8) Pv't. Co. H - 4th Pa. Cav. Enrolled 10-14-61 at Franklin, Pa. M/in 11-18-61 Harrisburg M/out and hon'd. 11-17-1864 at Petersburg, Va. 22 yrs.,5 ft. 4 inches, dark, hazel eyes, black hair. Born Onondago Co. N. Y. Cooper at Onondago."
